**CIRCULAR**

WCD, Govt. of NCT of Delhi is implemented "Ladli Scheme" since 2008 for empowerment of girl children born in Delhi. The eligibility criteria of the scheme are given below:-

- Girl should be born in Delhi as shown by the birth certificate issued by the Registrar (Births & Deaths) MCD/NDMC.
- The applicant must be a bonafide resident of the National Capital of Territory of Delhi for at least three years preceding the date of the birth of the girl child.
- Annual family income should not exceed Rs. 1 lac.
- If girl is school going, her schools must be recognized by Delhi Govt./MCD/NDMC.
- Benefit of the scheme is limited to two surviving girls per family.

Director WCD vide DO letter dated 20.10.2020 stated that (copy enclosed) are responsible for new registration and renewal of ongoing cases under the above scheme. During 2020-21 less than expected number of new registration as well as renewal cases has been received by the department of WCD, GNCTD. As a result this will not only impact on future allocation of funds due to poor utilization in the current year but will also deprive many underprivileged girls of the much needed financial assistance under the above scheme.

Therefore, all HOSs of Govt./Govt. Aided & Pvt. Recognized schools of Delhi are directed to look into the matter personally and guide the parents and do handholding to ensure the registration of fresh as well as renewal cases with concerned district offices of department of WCD, GNCTD by 31.12.2020 under the scheme.
